#### NEW SCHOLARSHIP ESTABLISHED IN POTTER MEMORY

A \$10,000 scholarship fund has been established at UND in memory of William Tod Potter, and Air Force captain missing and presumed to have been killed in Vietnam.

Established by the Vukasovich Foundation of Watsonville, Calif., the scholarship will be given annually to a student enrolled in the College of Business Administration at UND and will be in the amount of \$500.

The scholarship is the second such award given annually in memory of Potter. His widow, the former **Betsy Schuster, '65**, established a \$200 annual scholarship in 1968 that is given to an Air Force ROTC cadet at UND.
