Conference To Explore Lignite Use

A conference about one of North Dakota's most current issues will bring 200 persons to the UND campus on November 8-9 to explore how the utilization of lignite to provide fuel for the nation will affect the state's land use, economic development and population patterns.

Invitations have been sent to legislators, county commissioners, news media representatives, scholars from the humanities, fuel industry leaders and coal technology experts.

The program format involves presentations by 18 speakers in the two-days of sessions, followed by response panels and discussion groups.

The conference will be opened by Gov. Arthur Link and is sponsored by the UND Engineering Experiment Station, the UND Division of Continuing Education and the North Dakota Committee for the Humanities and Public Issues. The project is supported in part by a \$11,600 grant from the North Dakota Committee for Humanities and Public Issues, an agency of the National Endowment for the Humanities.

Alan G. Flecher, dean of the UND College of Engineering, stated that "the conference is based on the premise that the humanities can join the sciences, business and government in contributing to an understanding of this public policy concern of major implication to North Dakotans.

North Dakota's lignite reserves represent nearly one-fourth of the nation's total coal reserves. In recent months, the state has been experiencing a "land lease rush" with large interests seeking rights to land and water so that lignite could be converted to electrical energy, pipeline gas, crude oil and other valuable products.

UND Aviation Department Is Unique in Nation

The University of North Dakota is unique in many ways, including an aviation department in the College of Business and Public Administration that is the only one of its kind in the nation.

John D. Odegard, chairman of the department, has noted a remarkable growth in the past six years with 550 students registered for aviation courses, 170 of them as majors.

For students interested in the business aspect of the aerospace field, the department offers a series of courses with an applicable aviation sequence to familiarize the students with the industry at all levels.

Other programs feature air-

line industry speakers who teach airline management. All graduates of the UND Aviation Department are equipped with a private pilot license and a commercial pilot license with an instrument rating as part of the required training.

Odegard indicated that the excellent quality of students in the program is reflected by the large number of job offers from the aviation industry. Job offers were running about four to one more than the number of graduates last year.

The department utilizes 26 airplanes in the flight school at the Grand Forks International Airport, with ground training facilities helping stu-

U Medical Program Moves Ahead

Another major step in the efforts to develop a degree-granting medical program in North Dakota was taken on October 17 when contracts with two Minnesota medical schools were given final approval by a committee of the North Dakota Legislative Council.

The Medical Education and Government Administration Committee voted unanimous approval of contracts between UND and Minnesota schools to provide one year of training for North Dakota medical students,

Thirty-five students will spend their third year at the University of Minnesota while five students will pursue a similar course at the Mayo Medical School in Rochester. All will return to North Dakota to complete medical degree work.

North Dakota will pay the University of Minnesota \$11,500 per student, while \$11,600 will be paid for each student at Mayo.

Dr. John Vennes of the UND Medical School stated that the contracts are part of a plan that includes medical training at four area health education centers and residency programs at North Dakota hospitals and clinics.

The contracts had been previously approved by the State Board of Higher Education and the program will be implemented next year. A provision of the contracts is that the Minnesota schools will not accept any of the UND students they train as transfers for their own fourth-year programs. This assures the return of the medical students to North Dakota for completion of training, hopefully to remain in the state after receiving their M.D. degrees. In

dents prepare for the job market in aviation.

There are three full-time faculty members, approximately seven part-time faculty and nearly 40 other employes involved in maintaining aircraft and staffing flight operations at the airport.

The air traffic control course is also showing rapid growth, training students for a career as air traffic controllers. Another course now being readied is in the area of training pilots to control such weather conditions as hail suppression, rain cloud seeding and thunderstorm flying.
