

MAN-IN-THE-SEA FACILITY: This is the intricate, sophisticated facility named "Manin-the-Sea" at UND. The component is 40-feet long, 20-feet wide and 9-feet high and is part of one of the world's largest and most advanced research projects to explore the possibilities of prolonged life under the sea.

One of the world's largest and most advanced research projects to explore the possibilities of prolonged life under the sea was dedicated on November 30, 1973, at the University of North Dakota.

The \$2 million project traces its beginnings to 1966 when teachers in the UND College of Engineering and the UND School of Medicine cooperated to build a small pressure chamber for research, with funding from the Office of Naval Research beginning in 1968.

The prime aim of the Man-

in-the-Sea project is research into the effects of submersion at depths to 1,320 feet. It is the only laboratory in the free world capable of studies of long-term effects of high pressure on the reproduction, nutritional needs and general health of test animals.

The Man-in-the-Sea facility has a major component that measures 40 feet long, 20 feet wide and 9 feet high; it occupies a 12-room suite in Upson Hall as well as six rooms in the Medical Science Building. Research from the project, which is staffed by UND faculty and students, has produced nearly 80 scholarly papers, dissertations and theses.

The project is directed by Thomas Akers, who notes that man is just beginning to explore the possibility of prolonged life under the seas. He estimates that construction of the Man-in-the-Sea facilities by private industry would cost between \$15 and \$20 million; by incorporating the design and construction as part of the over-all research and the training of staff members and students, the total cost was held to about \$2 million.

Welk Foundation Gives \$4,000 Music Scholarship

The University of North Dakota has received a \$4,000 grant from the Lawrence Welk Foundation, according to J. Lloyd Stone, executive vice president of the UND Alumni Association.

Stone said that the money

will be used for music scholarships.

A native of Strasburg, Welk returned to UND in October to lecture to a history class and direct the UND band as a visiting professor of the popular arts. In 1959 Welk was presented the UND Alumni Distinguished Service Citation in recognition of his achievements and loyalty to North Dakota. More than half the state chairmen have accepted responsibilities to oversee campaigns within their areas, and more than 700 UND alumni have already made contributions during the current campaign.



Libby Collection Increases

The Orin G. Libby Manu-script Collection at UND has doubled in size during the past six years, according to Daniel F. Rylance, Libby curator.

The historical collection was begun in 1950 and holds personal papers, letters and manuscripts of 209 prominent North Dakota politicians, educators, authors, public figures and organizations. The materials occupy about 3,000 lineal feet of space in the Chester Fritz Library.

The collection is named in honor of Orin G. Libby, who

taught at UND from 1902 to 1945 and is known as "the father of North Dakota history." The papers of 12 former North Dakota governors are in the collection because many were UND alumni and because the University has graduate programs where the papers can be used frequently.

The collection accepts any correspondence or records concerning Northern Great Plains history; persons wishing to deposit papers or other materials should contact Rylance at UND.

Fund for Blind Programmer

Efforts are being made to provide an electronic device for Elmer Morlock, '61, a blind computer programmer at UND, with a goal of \$5,000 to purchase the machine and train Morlock in its use.

The device, called an Optacon, picks up visual information from a printed page and converts the information into different touch sensations in the user's hand. With it, Morlock would be able to read ordinary printed material without the aid of braille texts, tape recordings or volunteer readers.

As part of the fund raising effort benefit dances and other entertainment are planned on the campus. Alumni wishing to share in the project can make contributions through the UND Development Fund, designating their gift to be used for the Morlock Optacon Fund.

A long-time resident of Grand Forks, Morlock is a graduate of the State School for the Blind and UND; he has been on the UND Computer Center staff since 1968.

University Computer Aids in Operation of North Dakota Dairy Farm

Glenn Endrud, '67, has joined his brother in a dairy operation near Buxton, N.D., and is using his engineering principles learned at UND in a type of "computerized farming."

He was the recipient of an

engineering scholarship at UND from Nodak Rural Electric Cooperative in Grand Forks. Glenn and his brother Lowell are partners in a dairy business that was featured in a recent article in the "Nodak Neighbor," RFC publication.

Glenn has "programmed" the UND computer so it will tell the best feed ration, and feels that the periodic rental of the computer has been very helpful in choosing feed rations for the dairy cows at the lowest cost.

There are several other innovative techniques in the dairy operation that reflect their engineering knowledge, including an automatic feeding system, an automatic barn cleaning system and other automated equipment.

The Grand Forks Seed Co. is giving financial assistance to the UND journalism department in its purchase of an electronic editing machine costing \$12,900.

The Grand Forks Seed Co. is giving a \$6,850 grant made possible through a Dow Chemical Company marketing award which was won by the firm. Three of the executives of the firm—Dick, Bob and Pete Smith—are all UND alumni and loyal supporters of the University.

The machine will be installed in time for journalism students to use it during the spring semester and will be one of only six comparable units in use by colleges in the

Upper Midwest Gains Physical Therapists

The Upper Midwest has gained nearly 40 physical therapists as the result of a six-year-old program at UND.

The University's physical therapy department, the only one between Minneapolis and Seattle, was established in 1967 to fill a need for professional physical therapists in the region.

Of the 55 therapists graduated to date, there are 23 practicing in North Dakota, 13 in Minnesota and two in South Dakota. Physical therapy is the treatment of disabilities caused by stroke and other conditions, and consists of heat, electricity, ultrasound, water, massage and exercise.

ASSISTANT NAMED

Douglas D. Crockett, a 1969 UND graduate, has been named assistant archivist at the Chester Fritz Library at the University. After serving in the U.S. Army for two years as a linguist, Crockett taught in Tennessee and lived for one year in South America.

Foreign Studies Expanded at U

The University of North Dakota is beginning participation in several national programs that will make it easier for students to earn credits toward their UND degrees while studying in foreign countries.

Foreign study and travel, particularly during the summer, has greatly increased in popularity among American college students. Under the new plan, the four programs specializing in international education for students are sponsored by New York State University, Wisconsin State, Brigham Young, and the Institute of European studies; the first UND students under the new plan are expected to go abroad during the spring of 1974.

Several hundred UND students have studied and traveled abroad in recent years through summer programs such as Experiment in International Living, "Europe 73," and through the Arneberg, Honve, Sons of Norway language and Max Kade scholarship programs. "Europe 74" is now in the planning stages, with several UND departments intending to offer field study programs for UND credit from May 14 to June 14 in conjunction with a charter flight.
