#### The following announcements were made:

- a. Ms. Hume reminded senators of the University Council meeting on Wednesday, April 21 at 3:00 p.m. in Swanson 16-18 (location later changed to the Memorial Union Lecture Bowl).
- b. The last Senate meeting of the year will be on Thursday, May 6. Emphasis was made on attendance to insure quorum.
- c. There was an update from Mr. Boyd regarding the nickname/logo issue and the State Board of Higher Education. First, Mr. Boyd reminded the senators of the background on the issue. On May 14, 2009 the SBHE met and directed UND to retire the nickname and logo as of a specified date, but the decision would be suspended if there was

approval of use by the two tribal councils and for a period not less than 30 years. Those conditions were not met but the SBHE delayed. There was a lawsuit filed in District Court by Spirit Lake tribal members. The District Court ruled in favor of the State. The group appealed to the Supreme Court. The ruling came down today, April 8, that the State prevailed. The SBHE was affirmed to have the power to make the decision on the logo. The Board is meeting today but no official action has been taken as of yet. If there is a decision today to retire the nickname and logo, the President will have a University forum at noon tomorrow, Friday, April 9. There will also be a website regarding the matter.

- d. Grant Hauschild, the new student body vice president, was introduced.
- e. Ms. Hume reminded the senators of the Time Out Week and Wacipi taking place next week.
- f. There was an announcement regarding a draft proposal for parking fees. Anyone is welcome to attend the meeting of the Parking Committee on April 21 in Swanson 16-18 regarding the proposal.

The March Senate minutes were reviewed. Approval was moved by Mr. Munski and seconded by Ms. Bass. The minutes were approved as distributed.

The question period was opened at 4:22 p.m.

- 1. Mr. Ullrich asked about parking fees that have to be paid annually rather than monthly for some employees. Mr. Munski shared that there is an attempt to not disadvantage anyone and the committee will work toward that end.
- 2. Ms. Kenville requested recognition and thanks to Lillian Elsinga for her many years of service on this, her last Senate meeting before retiring. The Senate gave her a round of applause in recognition of her efforts.
- 3. Mr. Murphy requested a report on the athletic move to DI: advantages, disadvantages, and financial impact. Ms. Hume indicated that she will work on getting a report for the fall semester.
- 4. Mr. Graziano asked about Essential Studies and Spanish not being approved for ES. Ms. Anderson reported that Spanish 101 and 102 were approved in, and effective for, fall 2009.

The question period closed at 4:30 p.m.

7.

The annual reports for the Academic Policies and Admissions Committee, Administrative Procedures Committee and Student Academic Standards Committee were reviewed. Mr. Perkins moved approval of all three reports. The motion was seconded by Ms. Kenville and the reports were approved to be filed.

8

The Senate committee election ballot for 2010-11 was presented by Ms. Goodwin. She explained that the senators need to approve and sign the ballot to make it official. Approval was moved by Mr. Ullrich and seconded by Ms. Kenville. The ballot was approved unanimously.

9.

The Curriculum Committee report and addendum were reviewed. Ms. Tyree, chair of the Committee, indicated willingness to answer questions. There were no questions. Ms. Kenville moved approval, Mr. Munski seconded and the motion was approved unanimously.

10.

The Academic Policies and Admissions Committee presented a proposal to add wording to the Final Exam section of the academic catalog. Mr. Munski, a committee member, was available for questions since the chair, Mr. Bridewell, was not able to attend. The proposal was to add language for clarity and consistency regarding timing of final exams for all classes including on-line classes. Mr. Munski moved approval. The motion was seconded by Mr. Perkins. Discussion ensued. Ms. Goodwin requested that the committee give more direction for resolution for three or more finals. Mr. Munski indicated he would pass that request on to the committee. The motion passed unanimously.

The Student Academic Standards Committee, an appeals board, meets upon demand. The Committee functions within the guidelines approved by the Senate on February 3, 1983, as revised in April, 1985, and again as revised on March 4, 1999. A summary of the year's Probation/Suspension/Dismissal, Reinstatement, Academic Grievance and exceptions to admission standards activities is indicated below.

Because of the confidential nature of the information about the students, the committee keeps no written minutes other than a statement about the action taken with respect to each student seeking reinstatement. When a grade grievance is the issue before the committee, minutes are kept of the entire proceedings.

The committee meets as needed, with the greatest demand usually occurring at a time immediately preceding the beginning of a term.

Fall 2008-Spring/Summer 2009, members held 16 meetings between the dates of September 23, 2008 and August 31, 2009. Fall 2009 to present, members began meeting on October 20, 2009 and have held 6 meetings to date.

#### **FINAL EXAMINATION POLICY**

An examination is held at the end of most courses according to the published examination schedule. Alternate evaluation methods and schedules may be used when recommended by the departmental faculty and approved by the dean of the college offering the course. Any change in time from the published schedule requires the recommendation of the chairperson of the department and approval of the dean of the college offering the course. Any student who would be disadvantaged by such a change should report this in advance to the dean of the college offering the course, who will ensure that satisfactory alternate arrangements will be made by the instructor. Final exams for all courses, oncampus and semester based online, will conclude on or prior to the end of the final exam period. No final exams shall extend beyond the final exam period.

A student who is absent from a regularly scheduled examination without an excuse considered valid by the instructor is normally given an F for the course. If the excuse is valid, the policy on incompletes will apply.

No undergraduate student should be obliged to write three or more finals on the same day. If the student has three or more finals scheduled the same day, the student wishing an accommodation regarding final exams should contact his/her instructors to establish a mutually acceptable time to reschedule one or more of the exams. Any student request for the rescheduled final exam must be presented to the instructor before the end of the tenth week of the semester, otherwise, the student's rescheduling right is forfeited. If an accommodation cannot be reached, he or she should contact the department chair(s) to find a mutually agreeable time. If no agreement is reached, the appropriate dean(s) should be contacted. The final appeal, if no mutually convenient time has been found, will be to the Vice President of Academic Affairs.
