Dear Senator Langer:

The food and clothing situation of the Indians on the Fort Berthold Indian Reservation has been brought to my attention by a Rev. P. C. Petersen, Van Hook, North Dakota.

I don't know as it is my place as a County
Extension Agent to start any action on this, but I
promised Rev. Petersen I would write to you. Rev.
Petersen, who serves part of the area as a Minister,
says he has visited the homes and he feels that unless the Indians are given more food some of them will
starve to death this winter.

We are aware of the fact that they have their agency down there, but the fact remains according to Rev. Petersen, that some of the Indians are definitely in need of food and clothing.

We are wondering if more of North Dakota's surplus potatoes cannot be shipped in there and distributed to help relieve the situation. Rev. Petersen stated that some had been shipped into Elbow Woods, but the Indians living at Sanish and Shell Village, which is some distance away, had not received any.

We should appreciate if you can give this matter your prompt attention.
