Dear Mr. Langer:

I have the honor to transmit to you herewith copy of my letter to the Commissioner of Indian Affairs, a copy of my wire, and copies of two Tribal Council resolutions extending invitation to the Commissioners office to send his duly authorized representatives to come to Fort Berthold Reservation for purpose of presenting and explaining the Bureaus approved plan to release all Tribal funds now on deposit in the U.S. Treasury to the credit of the Three Affiliated Tribes.

In view of my recent unsuccessful efforts to appeal the Commissioners decision. I am very much pleased that this action has been taken by the Tribal Council to extend invitation to the Commissioner of Indian Affairs to send representatives to come to the Reservation, So that the people will have chance to see and argue for themselves about the situation. It takes me out of bad situation and I am greatly relieved.

I will make a personal report to you as to findings of facts and the results of this proposed conference.

Please keep the matter open until further notice.

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS; A motion was made and duly seconded and was carried by Five for the motion. One against and One abstention, that the Three Affiliated Tribes do extend invitation to the Commissioner of Indian Affairs that he sent representatives from the Indian Bureau of Washington Central office and Aberdeen Area office for purpose of presenting and explaining to the members of the tribe, the Bureau approved comprehensive plan for reeducating and reorienting the position of the tribes as a prerequisite to the full release of Tribal funds held in the United States Treasury to the credit of the Fort Berthold Indians, and
- WHEREAS; Indian people present at the Council meeting on June 3, 1954 unanimously favored the extending of the invitation to the Bureau officials, and
- NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation that an invitation is hereby extended to the Commissioner of the Indian Affairs to send Indian Bureau officials of both Central office and Aberdeen Area Office to the Fort Berthold Reservation for purposes of explaining the proposed full per capita payment plan designed by the Bureau.
- Provided that the transportation and expenses of Bureau representatives be borne by the Indian Bureau and not charged to the Three Affiliated Tribes.
