#### PRESIDENT WILLIAM G. OWENS DIES

Funeral services were held in the Congregational church at Williston Wednesday afternoon, March 21st, 1945, for William G. Owens, who died in his sleep Sunday morning. The Rev. N. E. Elsworth of the Episcopal church conducted the services and interment was in Riverview cemetery.

Prior to the services in the church more than 100 members of the Elks, many from all parts of North Dakota, attended the Elks memorial service held in the Everson Funeral Home chapel.

Mr. Owens recently began his second term as county judge, and was at the time of his death president of the State Bar Association, which he represented as honorary pall bearer at the funeral of Sen. John Moses. He was past exalted ruler of the Elks lodge and had served as state deputy grand exalted ruler, president of the North Dakota state Elks association and treasurer of the Williston lodge for a number of years.

He was born at Leavenworth, Minn., July 7, 1877, graduated from the high school at Sleepy Eye and in 1900 graduated from the Law College of the University of Minnesota with the degree of Bachelor of Laws. He opened a law office at Walnut Grove, Minn., and came to Williston in 1910 to take over the law practice of A. L. Knauf, when the latter moved to Jamestown.

He was a member of the North Dakota legislature in 1913 and was elected state's attorney of Williams county in 1915, serving two terms, whereupon he was appointed assistant attorney general.

During the Hoover administration he was appointed attorney for the federal farm board, and in 1933 he returned to Williston and resumed his law practice, which he continued until his election as county judge.
