ANNUAL MEETING OF THE NORTH DAKOTA STATE BAR ASSOCIATION

When you arrive at Fargo for the Annual Meeting of the North Dakota State Bar Association, August 29th and 30th, you will find everything in readiness for a good live meeting with various events just waiting to happen when their appointed time arrives.

To avoid congestion on the first morning of the assembly, a registration desk will be operated in the lobby of the Gardner Hotel Wednesday evening, August 28. On the following days registration will take place in the main hallway on the third floor of the Federal Building. It is urged that you register as early as possible and be sure to obtain your badge and banquet tickets at the same time. Women will register at the same desk. All business and sectional assemblies will be held on the third floor of the Federal Building.

The program opens Thursday morning with the call to order, invocation and addresses of welcome. The annual address will be delivered by President Clyde Duffy followed by reports of standing committees. At ten thirty an address will be given by Albert M. Kuhfeld on "Code Revision," which should be of great interest to everyone. A special meeting of the First Judicial District Bar Assocation is to be held at eleven fifty-five.

The gathering goes over to the Elks Temple at noon for a buffet luncheon which will have the double virtue of no charge and no program, giving the members an opportunity for complete relaxation.

The afternoon session opens at one-thirty with an address, "The Philosophy of Force" by Honorable David A. Simmons of Houston, Texas, member of the Board of Governors of the American Bar Association, former president of the Houston-Galveston District Bar Association and of the Texas State Bar Association. He is well known as an interesting speaker and discusses a subject of deep concern to every thinking person. Following the address, distinguished guests will be presented to the assembly.

At three o'clock the Sectional Assemblies open for round table discussions on the following subjects: "Code Revision" with Vernon Johnson chairman and A. M. Kuhfeld discussion leader; "The Probate of An Estate in North Dakota" with Judge Joseph J. Funke chairman and Norman S. Tenneson discussion leader; "The Frazier-Lemke Bankruptcy Law" with Charles L. Foster chairman and John J. Nilles discussion leader. These discussions present a wonderful opportunity to iron out problems that arise on these subjects in the everyday practice of law and it is hoped that everyone will take part freely.

The President's Reception will be held at the Elks Temple at five-thirty and at six o'clock the traditional Annual Dinner will be held at the same place. Following the dinner the entire assembly is invited to see the Evening Revue at the Red River Valley Fair as guests of the Cass County Bar Association. Dinner will be served promptly at six and will be over in time to arrive at the Fairgrounds at eight o'clock. A special section has been reserved and as the Fair has an exceptionally fine show scheduled a very enjoyable evening is anticipated.

On Friday morning the assembly opens at nine-thirty. Committee reports will be followed at ten o'clock by the second division of Sectional Assemblies at which the following subjects will be up for discussion: "The Foreclosure of a Real Estate Mortgage in North Dakota" with Chas. M. Pollock chairman and A. M. Kvello discussion leader; "Problems in Criminal Law" with Nels S. Johnson chairman and Milton K. Higgins discussion leader; "Problems Regarding the Examination of Abstracts" with Lester T. Sproul chairman and Harry A. Bronson discussion leader.

At noon various group luncheons will take place. The meeting will reconvene at one-thirty to hear committee reports, take care of unfinished business and elect officers for the coming year. Attendance prizes consisting of ten valuable law books, \$150.00 worth to be exact, which have been contributed by the law book companies, will be awarded at that time to those present at the assembly.
