LAY ON, MACDUFF

Under date of November 6th, the Associated Press dispatched from Lincoln, Nebraska, the following statement credited to the Governor of North Dakota:

"I wish Governor Bryan wouldn't pay so much attention to the Constitution. I hoped he'd say the Constitution doesn't mean anything in Nebraska—and I don't think it does."

There is no racketeer more dangerous to a constitutional democracy than the public official who, by reason of his opportunity to invoke power, makes use of that power in contravention of the ordinary rules of decency and the specific provisions of the Constitution he has sworn to defend and support.

The military IS SUBORDINATE to the civil power; and NO PERSON shall be deprived of life, liberty or property WITHOUT DUE PROCESS OF LAW.

We challenge the right of any man, no matter how seemingly great or powerful, to violate those principles.

AMERICAN BAR PROGRAM
