Of these 47 approved acts, North Dakota has enacted 11 into law, which are as follows, according to the report of the National Conference: Acknowledgment Act; Aeronautics Act (1923); Declaratory Judgments Act (1923); Desertion and Non-Support Act (1911); Illegitimacy Act (1923); Motor Vehicle Anti-Theft Act (1927); Motor Vehicle Registration Act (1927); Motor Vehicle Act Regulating Operation of Vehicles (1927); Negotiable Instruments Act (1899); Sales Act (1917); Warehouse Receipts Act (1917).
