Special provision is under way for the ladies. It is the plan of the committee, however, that time shall be afforded to them to attend the sessions of the association at which the principal addresses are given. Meetings in all probability will be held at the Capitol. The attendance last year approached the two hundred mark. It should be more this year. Among the principal speakers will be Chief Justice Harry Olson of the Municipal Court of Chicago, long prominent as a judicial administrator, president of the American Judicature Society, and a pioneer in the psychiatric examination of persons accused of crime. Chancellor Brannon of the University of Montana will speak on "The Relation of Law to Social Evolution." Dean O. P. Cockerill of the law school of the University of North Dakota will speak on a subject to be announced later. Other speakers will be announced later.
