## EXECUTIVE COMMITTEE

The Executive Committee, consisting of the President, Vice-President, Secretary, and the following appointive members: V. R. Lovell of Fargo; John Knauf of Jamestown; T. F. Murtha of Dickinson; Wm. Hutchinson of LaMoure; Horace Bagley of Towner, and G. S. Wooledge of Minot, met at Bismarck on Oct. 6th. All members were present except Murtha and Wooledge.

The President and Secretary were directed to edit the record of the annual meeting, publishing the summary of remarks made on the floor, except where the matter was of such importance as to require it to be given verbatim.

Twelve bids for printing the 1925 Proceedings were received, opened and considered. The bids ran from \$1.85 to \$4.00 per page for printing, and from \$1.50 to \$9.00 for inserts. The Quick Print of Bismarck being the lowest and best bidder, was awarded the contract.

Bismarck was determined upon for the place of the 1926 meeting, the time of the meeting to be fixed later.
